

VOLUNTEER POLICY

Volunteer Policy

The Online Memorial and Museum of Prisoners of War is run by and resourced entirely with volunteers.

We recruit volunteers through our Facebook forums and the charity's website. https://www.prisonersofwarmuseum.com/

This and our other policies, describe how we ensure that we treat all volunteers with fairness and equity.

The trustees will proactively engage with volunteers to ensure that they are able to contribute in ways which are rewarding and fits their circumstances. We will make reasonable adjustments to the charity's work where necessary to do so.

Volunteer induction and training is delivered through a combination of personal interaction and written instructions.

Volunteers will be given a Role Description.

Volunteers will be supervised and supported by a trustee and, where appropriate, one or more other named volunteers.

Most volunteer contributions are delivered from the volunteer's home using their own IT or other equipment. It is the volunteer's own responsibility to ensure they have a safe environment from which to contribute.

Volunteers are expected to keep confidential all personal information that they receive. Volunteers will be asked to sign a confidentiality agreement.

If anything occurs which a volunteer considers a problem or they have cause to complain they should raise these in the first instance with one of the trustees.

Volunteers:

- may contribute as much or as little time as they choose to support the charity;
- are not paid for their contributions to the charity but may, with prior approval from the trustees, reclaim any directly incurred out-of-pocket receipted expenses associated with the activities they do:

- must be over 18 years of age.
